The 15th Annual Gingerbread Celebration & Holiday Market will be held in conjunction with the Gettysburg Christmas Festival at our Arts Education Center, 125 S. Washington Street.

The public is invited to shop while viewing and voting for Gingerbread Houses and bidding on Silent Auction Baskets. The market will be promoted on our website, social media pages, E-blast/E-Press, and various local news outlets. We encourage you as a vendor to share this information with your contacts, customers, friends, and family. Follow our Facebook and Instagram accounts, and share posts about the event with your social networks.

- Vendor's fee is \$75 (\$65 for ACAC members), nonrefundable and payable to the Adams County Arts Council.
- Electricity (limited availability) is an additional \$20 cost. Vendor space is limited and will be filled at the discretion of ACAC.
- Vendor's space is 6'x6'. Vendors must provide tables, covered to the floor. Two chairs are included.
- Vendors must set up between 9 a.m. and 4 p.m. on Thursday, Dec. 5 or between 9-11 am on Friday, Dec. 6 in ACAC Gallery.
- Vendors must be present during event hours: Friday, Dec 6, 12-7 p.m.; Saturday, Dec 7, 10 a.m.-6 p.m.; Sunday, Dec 8, 10 a.m. - 2 p.m. Tear down can begin at 2 p.m. on Sunday.
- Vendor products must be hand-made and/or artisan pieces.
- Vendors must handle their own transactions, collect, and report 6% sales tax as applicable.
- *By completing and signing the Vendor Form, Vendors and their representatives waive, release and discharge the Adams County Arts Council (ACAC) and any of its officers, agents, employees, principals, owners, affiliates, subsidiaries and partners (collectively, "Indemnified Parties"), from any and all liability, including but not limited to, liability arising from the negligence or fault of the Indemnified Parties, illness (including, but not limited to, COVID-19), death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur
- Vendor forms must be received by Friday, November 8, 2024.
