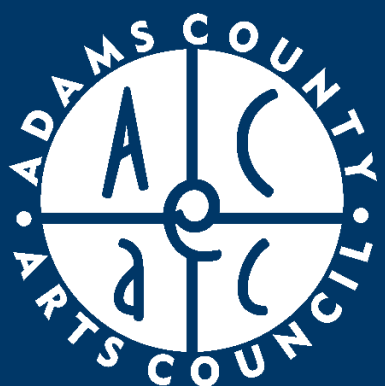


ADULT CLASSES at the AEC

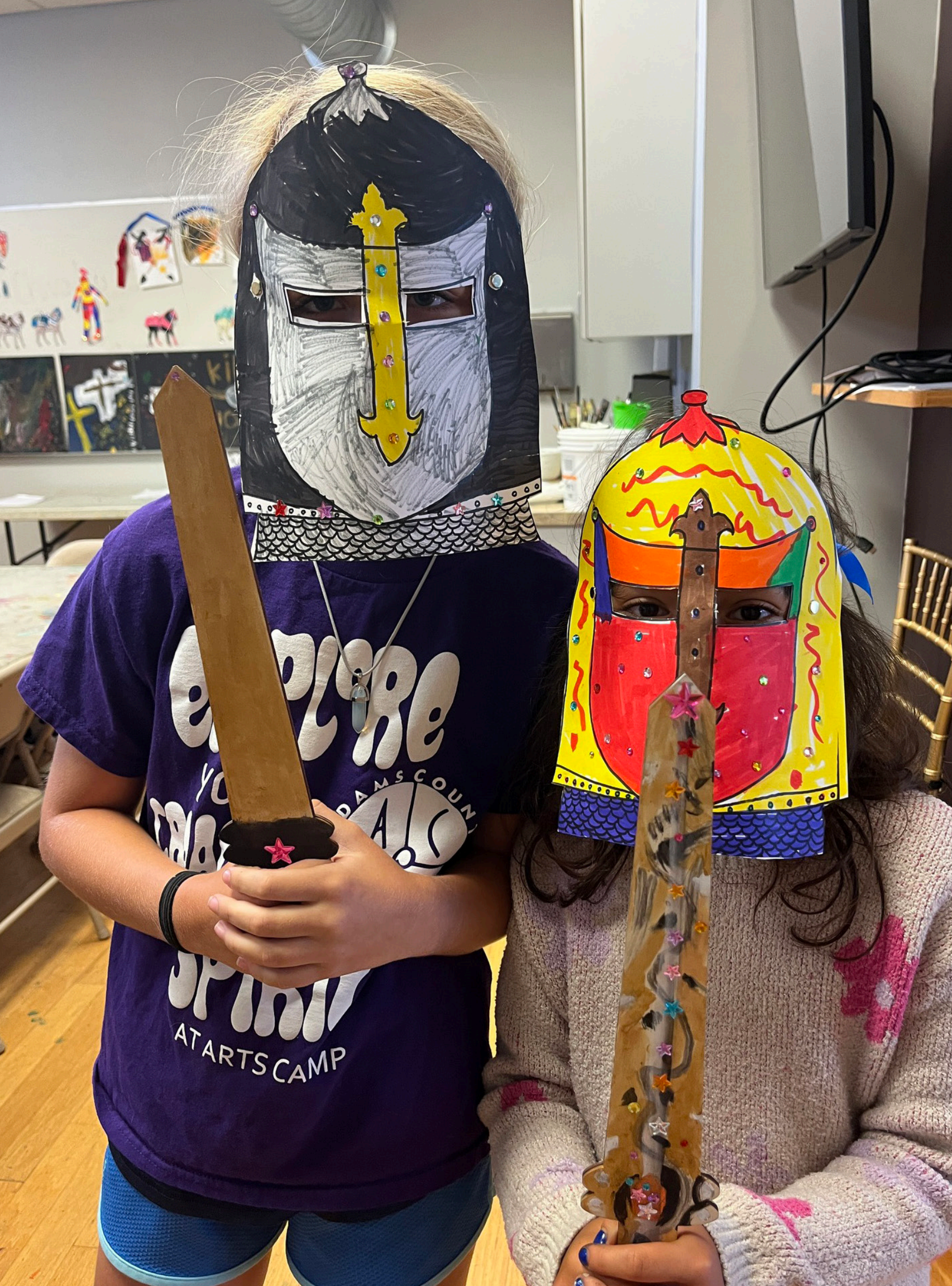

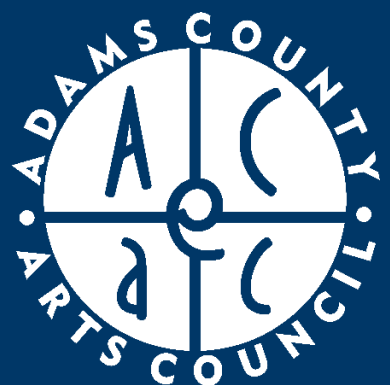

- 529 artists



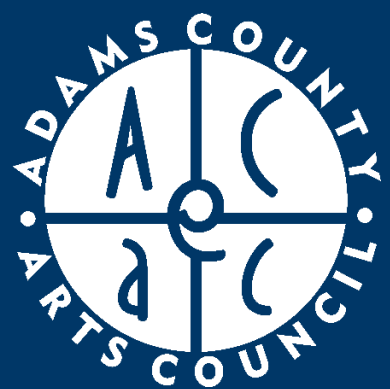

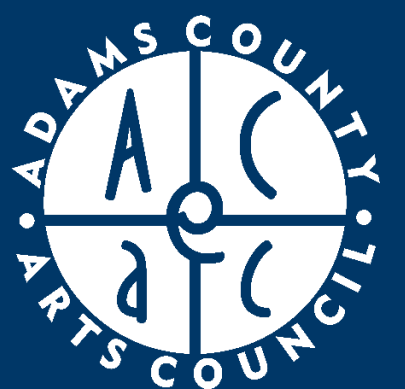
